Comments: Ms. Simpson discussed with the board the brownfield grant awards received from NJ DEP and U.S. EPA for the Federal Street Corridor as announced at the June 2024 Meeting. She informed the board companion Resolutions A-F were presented to recommend contracts be awarded for required LSRP and environmental services for the Federal Corridor sites. Specially, the NJ Hazardous Discharge Site Remediation Fund and U.S. EPA brownfield grants will cover remedial activities at seven (7) targeted publicly owned sites and move forward potential clean-up and productive reuse of these strategic locations. She informed members Ms. Christina from BRS, Inc. was present to assist in responding to questions.

Ms. Simpson asked Chairperson Leonard to hear Resolution 07-10-2024 out of order.

the City of Camden Parking Authority for Temporary Public Parking

Comments: Ms. Simpson provided the board with a summary discussion, reflecting on the necessity for this action. CRA owns several vacant lots in the 3rd Street and Benson Street area of Block 155. Lanning

Square residents of the area have repeatedly expressed security, lighting, and maintenance concerns. The Mayor in consideration of alleviating these negative impacts on the community coupled with the city's need to meet the demand for additional parking for nearby waterfront and concert events, requested CRA work with PACC. She emphasized that the resolution authorizes the temporary lease of certain CRA owned lots in Block 155 to PACC. CRA and PACC met with the leadership of the neighborhood on June 26, 2024 prior to this board meeting.

Mr. Wiltsey (attorney for PACC) re-stated the lease of CRA owned parcels is only an interim plan based on a short-term agreement to meet the parking demand and promote good stewardship of these area lots for the Lanning Square neighborhood. PACC will install improvements that include temporary lighting and fencing. Space when not in use will be available for lease by PACC to the community.

Ms. Coleman, representing an adjacent property owner – the New Mickle Baptist Church, spoke stating the short-term lease of these properties is a good partnership with the CRA, PACC and the neighborhood. She thanked the CRA and PACC for helping to enhance the neighborhood and its quality of life.

Comments: Ms. Simpson asked the board to recall the CRA was awarded two brownfield grants, totaling \$1.1 million for the assessment and investigation of the seven (7) sites along the Federal Street Corridor. She stated it has taken two years to secure the funding to jump start clean-up of the Corridor sites.

Ms. Christina stated the two major grants target the sites (1) NJ HDSRF financing for the assessment/investigation of the sites (2) US EPA Grant for redevelopment planning and remediation. CRA also secured a brownfield clean up grant for the City's Borden Chemical site, which is the subject of this resolution. The remaining three companion resolutions will be funded by the NJ HDSRF grant. Ms. Christina informed the board awarding several rather than one contract was done to consider the cost and scheduling efficiencies for site clean-up, allowing a competitive process for several contractors to bid on separate sites and subsequently (based on contract awards), undertake work at same time.

Ms. Simpson asked the board to consider the Federal Street Corridor is over 11.7 acres of which 43% is publicly owned and the subject of heavy past industrial uses. We can do something impactful for the area in concert with other infrastructure improvements by the City and County that are underway along the Federal Street Corridor.
